Other Info:

- Open to all breeds and All American dogs. Handicapped handlers and dogs are welcome.
- Entries limited to 100 each trial; 2 trials each day
- (Run order: Level 1-trial1, Level 1-trial 2; Level 2-trial1, Level 2-trial 2, etc. with Diversions and Investigator run once at the end of each day as a part of Trial 2.)
- Open Date: July 15, 2018
- Close Date: August 11, 2018 (for pre-entries) (\$15 each)
- Late (after Aug 11, and Day of Show Entries until limits are met: \$20 each) (This includes any entries postmarked after Aug 11.) Mailed entries requiring our signature will be refused. Cancellations after Aug 11 will not be refunded unless they are due to a female in season or a dog injury with a signed veterinarian statement. A service fee may be charged.
- No FEO (For Exhibition Only) entries
- Indoors on rubber matting; indoor crating space; air conditioned building
- Competitors are responsible for reading the rules prior to entry. Rules are found at www.C-wags.org.
- A light lunch will be available each day for \$5.
- No Resets - one dog per handler at any level
- Awards: Qualifying ribbons; Title Rosettes
- Same day moveups allowed


















Directions: Sportsmen's is located 1 block south of I-696 & Dequindre.

C-WAGS Notice to Exhibitors

-  Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS rules and regulations including but not limited to the following rules regarding entry:
-  All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
-  All judges and trial hosts are expected to show respect to all exhibitors.
-  This trial is open to all dogs registered with C-WAGS.
-  Teams may be entered in multiple levels/classes at the same trial.
-  Dogs must be handled by the registered handler or immediate family member.
-  Collars: The dog must wear a flat type collar (buckle, snap or proper fit martingale) and/or body harness in the ring. Electronic training collars are not allowed on the show grounds.
-  Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
-  Safety shall always be a foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
-  In addition, the organizing committee may refuse any entry for any reason.
-  THERE SHALL BE NO REFUND for entries in the event a dog and/or handle are dismissed from competition, regardless of reason for such dismissal.
-  There will be no refunds if the trial is cancelled for any reason.
-  Refunds (less a service fee) will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.
-  Returned checks do not constitute a valid entry. There will be a \$35.00 service charge for returned checks. Payment of entry fees and service charges shall be made by money order within 7 days of notice to exhibitor of returned check. Any fees not received within 7 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
-  All competitors through entry at this event waive any and all rights relative to video broadcast of this event.
-  Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
-  Dogs must be on leash while on show grounds unless being shown. Please pick up after yourself and your dog. Those not cleaning up can be fined.
